"Leveraging Web-Based Technology in Supporting Fire and Life Safety System Performance" Presented by: Jill C Cotton, President of InspectionReportsOnline.net (IROL)

Inspection, testing and maintenance (ITM) prescribed in NFPA 25 and 72 assist in improving system reliability and performance which have direct benefits toward the fire and life safety environment. Descriptive research has been utilized to examine the processes associated with the ITM documentation and reporting of fire alarm and suppression systems and the delivery of critical data needed for fire departments/prevention bureaus to address impediments to their current process.

This program addresses the workload and staffing of today's modern fire prevention bureau which directly affects the number and quality of programs and enforcement activities that can be supported. A thorough understanding of the processes and supporting analytics underscores the importance of addressing system deficiencies in a timely manner and allows the bureau to investigate the benefits of integrating technology into their current solution to meet desired goals and objectives.

Research based on the examination of this multi-jurisdictional data has shown that leveraging web-based technology has positive impacts on system readiness through the effective management and processing of all reports generated by service providers. Enhanced comprehension of the problems within one's jurisdiction allows the Authority Having Jurisdiction (AHJ) the ability to tailor their compliance strategies and communicate directly with all stakeholders to further increase efficiency. This collaborative partnership assists in reducing the administrative overhead and has tangible benefits to the AHJ in today's tight fiscal environment.

Implementation strategies are discussed to underscore the importance of developing a comprehensive plan that engages the various entities to support the goals of sustainability and best practices in prevention, community risk reduction and life safety.
